

2021 WORLD JUNIORS HOCKEY CHAMPIONSHIP SEAT PURCHASE TERMS & CONDITIONS

- 1. Agreement:** I acknowledge and agree that these terms and conditions, together with all ticket order and account information submitted by me, constitute a binding legal agreement (the "Agreement") between Oilers Entertainment Group Canada Corp. ("OEG"), and myself. This Agreement supplements the terms and conditions printed on each Seat Ticket (the "Ticket Back Terms") which also apply to me and any individual using any of my Seat Ticket(s) from time to time. If any of the terms and conditions of this Agreement conflict with the Ticket Back Terms, the terms and conditions of this Agreement shall prevail to the extent of the conflict. By accepting delivery of the Seat Ticket(s), or by tendering payment to OEG, I have signified my acceptance of all of the terms and conditions of the Agreement and Ticket Back Terms and I confirm my agreement to remit payment in accordance with the terms corresponding to the Payment Plan I have selected.
- 2. Account Holder:** I hereby warrant that I am the Account Holder or an officer of the Corporate Account Holder, as the case may be, and have the authority to enter into and sign binding agreements on behalf of the Corporate Account Holder.
- 3. Seats:** I agree to purchase the Seats requested by me at the prices set by OEG, on behalf of the 2021 World Junior Hockey Championships, and that the payment for the Seats will be paid according to the Payment Plan I selected. I acknowledge and agree that the Seats being purchased are solely for the games of the 2021 World Juniors Hockey Championships (the "2021 World Juniors") presented by Hockey Canada and OEG and played at Rogers Place and the Downtown Community Arena in Edmonton under the package that I have purchased, and for the avoidance of doubt, shall not include tickets, or the right to purchase tickets, to any other event or game, including, but not limited to, 2021 World Junior Hockey Championship games held in Red Deer, or otherwise in which the World Juniors Hockey Championship teams participate. I acknowledge and agree that OEG or Hockey Canada may cancel, postpone, reschedule or relocate games or events for any reason, as determined in its/their sole discretion, as well as to modify or discontinue, temporarily or permanently, any aspect of the rules, operations and presentations of 2021 World Juniors games and events ("Preemption"). In the event that any game or event for which the Seats have been sold to me is not played or presented in Rogers Place and the Downtown Community Arena in Edmonton for any reason, including, but not limited to, Preemption, such event shall in no way be deemed, argued or construed to be a breach by OEG of this Agreement, any terms, conditions, agreement or any other duties or obligations in connection with the sale and use of these Seats and, in such event, my sole remedy shall be an account credit or refund equal to a proportionate share of my Seat package's ticket value established by OEG for the respective 2021 World Juniors game, and I hereby waive and release any and all claims I may have against OEG and Hockey Canada with respect to such game(s) or event not played or presented at Rogers Place and the Downtown Community Arena in Edmonton. I acknowledge and agree that, subject to the termination rights specified herein, this Agreement is for the 2021 World Juniors Hockey Championships and will expire on January 30 following the 2021 World Juniors Hockey Championships for which the Seats have been purchased. The purchase of the Seats for the 2021 World Juniors Hockey Championships does not entitle me to renew any Seats for any subsequent championships or events. Neither party has the right or obligation to renew this Agreement.
- 4. Use of Tickets:** The Seats and the Seat Ticket(s) may not be used for any commercial or trade purposes, including, but not limited to, advertising, promotions, contests or sweepstakes, without the express written consent of OEG.
- 5. Payment Plan:** I agree that OEG shall debit my credit card for the Seats requested by me and all handling fees and applicable taxes according to the Payment Plan I have selected and in accordance with the terms of the Agreement, unless I have selected an approved payment option such as cheque or debit card, in which case I agree that I shall submit the required payments under the Payment Plan I have selected by cheque or debit card for the Seats, any Parking Passes or Club Passes requested by me and all handling fees and applicable taxes according to the Payment Plan I have selected and in accordance with the terms of the Agreement.
- 6. Return of Seats:** In the event that I am unable to use, or wish to return any of the Seats, I understand and agree that I am still responsible for the full payment for all of the Seats to be paid according to the Payment Plan, and that OEG is not obligated to refund any money to me for any ticket purchased as part of the Seats under the Agreement.
- 7. Acceptance of the Seats:** By accepting delivery of the Seat tickets and any Passes I agree to purchase, I confirm my agreement to remit payment in accordance with the terms corresponding to the Payment Plan I have selected and I accept and agree to the terms and conditions in this Agreement and on the Seat Ticket.
- 8. Revoked Payment:** In the event that I have not submitted full payment for the Seats on or before the required dates of the Payment Plan I have selected, or if any payment provided by me is returned to OEG, or if my authorization to debit my account is revoked prior to all payments being made pursuant to the Agreement, I hereby authorize OEG to debit the credit card I have provided for the entire outstanding amount owed to OEG pursuant to the Agreement. I also hereby authorize OEG to debit the credit card I have provided with a \$25.00 service charge for each dishonoured payment as it occurs.

- 9. Interest:** OEG may charge interest at a rate of 2% per month (24% per annum) on the entire portion of my account balance that is not paid when due.
- 10. Termination:** All Seat tickets sold for 2021 World Juniors games are owned by OEG, and a 2021 World Juniors ticket is a revocable license issued to the Account Holder. OEG may, at OEG's sole discretion, terminate the Agreement and cancel any or all of my Seats if I fail to make required payments when due, or if I or the holder of the Seat ticket to any 2021 World Juniors game fail to comply with all laws or any facility, OEG, Ticket Back Terms or other applicable rules
- 11. Amendment:** I acknowledge and agree, that from time to time, OEG may amend this Agreement or the Ticket Back Terms upon notice to me. If this Agreement or the Ticket Back Terms are amended, OEG will provide me with an updated copy.
- 12. Assignment:** I may not assign or transfer the Agreement or any of my rights hereunder, in whole or in part, without the prior written consent of OEG, which may be unreasonably withheld. OEG may assign or transfer the Agreement to any person without my consent.
- 13. No Waiver:** No waiver or delay in enforcement of any breach of any term of the Agreement or Ticket Back Terms shall be construed as a waiver of that or any other term of the Agreement or Ticket Back Terms, and, without limitation, the acceptance of any payments specified to be paid by me hereunder shall not be, nor be construed to be, a waiver of any breach of any term of the Agreement or Ticket Back Terms.
- 14. Severability:** Each of the provisions contained herein and in the Ticket Back Terms is distinct and severable and a declaration of invalidity or unenforceability of any such provision by a court shall not affect the validity or enforceability of any other provision.
- 15. Personal Information and Privacy:** I hereby grant to OEG consent to use the personal information provided in the Agreement to provide me with the products and services I have requested, for the continued administration and maintenance of my ticket account and my on-going relationship with OEG in accordance with the OEG Privacy Statement.
